NOW THIS MEMORANDUM OF UNDERSTANDING is agreed by and between both the Colleges hereto as follows:

1. CHANDIDAS MAHAVIDYALAYA and BARRACKPORE RASTRAGURU SURENDRANATH COLLEGE have the necessary permission of the concerned Governing Bodies regarding the MoU.
2. 4. **Library facilities:** Resources of both the colleges can be shared, *modus operandi* of which will be settled jointly by the Library departments of the colleges.

6. Both the colleges have agreed that if additional assistance is required in that event Principal of both colleges will settle mutually after discussions.

7. That in respect of the above-mentioned programs and/or activities only Principals of both the colleges will take all responsibilities regarding selection of candidate(s)/participant(s) and other matters of the said purpose.

8. If any disputes arise in respect of this MOU in that case Principal of both the colleges will discuss and settle the matter amicably.

9. Both the colleges have entered into this Memorandum of Understanding for the period of two years in first phase.
