**1 | LINKAGE BETWEEN BRSC & BARRACKPORE AVENUE
WOMEN'S CULTURAL & SOCIAL WELFARE SOCIETY**

THIS LINKAGE AGREEMENT is made on this. ¹²27th Day of February 2023 BETWEEN **BARRACKPORE RASTRAGURU SURENDRANATH COLLEGE** , BARRACKPORE, UGC approved, 4th Cycle NAAC accredited , affiliated to the West Bengal State University, and Government of West Bengal aided college, of 85, Middle Road and 6, Riverside Road, P.O. and P.S. Barrackpore, District North 24 Parganas, West Bengal, Pin 700120, represented by its **Principal** hereinafter referred to as the First Party (Which term or expression shall unless excluded by or repugnant to the context, be deemed to mean and include its successor in office, representatives, administrators, and assigns) **ON THE ONE PART**

AND

BARRACKPORE AVENUE WOMEN'S CULTURAL & SOCIAL WELFARE SOCIETY, 58, S N Banerjee Rd, Dhobighat, Barrackpore, West Bengal 700120 with a motto to conduct outreach activities and disseminate valuable knowledge, **OF THE OTHER PART.**

WHEREAS **BARRACKPORE RASTRAGURU SURENDRANATH COLLEGE**, **BARRACKPORE** and **BARRACKPORE AVENUE WOMEN'S CULTURAL & SOCIAL WELFARE SOCIETY** recognizing the value of cooperation, have agreed to enter into this Linkage Agreement regarding outreach activities and dissemination of valuable knowledge. The purpose of this non-binding linkage is to make possible an institute academic Linkage for conducting outreach and knowledge exchange between **BARRACKPORE RASTRAGURU SURENDRANATH COLLEGE**, **BARRACKPORE** and **BARRACKPORE AVENUE WOMEN'S CULTURAL & SOCIAL WELFARE SOCIETY**, based upon the principles of mutual equality and the reciprocity of benefits.

NOW AGREEMENT WITNESSETH and it is agreed by and between both the Parties hereto as follows:

1. Each party will accept visiting members from the other party.
2. That the exchange programme shall include exchange of knowledge specially on gender sensitization and cultural aspects and the spreading of peace via knowledge of Restorative Justice practices.

3. The exchange programme is to encourage college students to support/ donate/ collect food medicines etc. for the poor orphanage kids
4. The number of members under the activities exchange programme shall be as per the requirement of the activity, and shall be decided and settled prior to the programme between the signatories of this agreement.
5. The Agreement shall stand valid for a period of Two years from the date of its execution. However, it shall be automatically renewed unless any party hereof communicates for its termination, with a prior written notification to the other Party, at least six months prior to the date of its expiry.
6. Both Parties shall comply with the relevant laws in the jurisdiction in which it is in situated, and that all the visiting members from either of the organisation shall comply with all relevant laws in the jurisdiction of the host party.
