AGREEMENT FOR LINKAGE BETWEEN

2 LINKAGE BETWEEN BRS, INDIA & KII

- That the activity exchange program shall include exchanges in terms of knowledge specially in Insurance Education and the exchange of research materials, publications, and information to facilitate academic interchange between the parties of this Linkage Agreement.
- The number of members under the activities exchange program shall be as per the requirement of the activity, and shall be decided and settled prior to the program between the signatories of this agreement.
- 4. The Agreement shall stand valid for a period of Two years from the date of its execution. However, it shall be automatically renewed unless any party hereof communicates for its termination, with a prior written notification to the other Party, at least six months prior to the date of its expiry.
- Both Parties shall comply with the relevant laws in the jurisdiction in which it is in situated, and that all the visiting members from either of the organisation shall comply with all relevant laws in the jurisdiction of the host party.
