

**AGREEMENT FOR LINKAGE

THIS LINKAGE AGREEMENT is made on this 28th Day of March, 2023 BETWEEN **BARRACKPORE RASTRAGURU SURENDRANATH COLLEGE , BARRACKPORE**, UGC approved, 4th Cycle NAAC accredited , affiliated to the West Bengal State University, and Government of West Bengal aided college, of 85, Middle Road and 6, Riverside Road, P.O. and P.S. Barrackpore, District North 24 Parganas, West Bengal, Pin 700120, represented by its **Principal** hereinafter referred to as the First Party (Which term or expression shall unless excluded by or repugnant to the context, be deemed to mean and include its successor in office, representatives, administrators, and assigns) **ON THE ONE PART**

AND

KOLKATA INSURANCE INSTITUTE, KOLKATA (Associated Institute of Insurance Institute of India, Mumbai) of Royal Insurance Building, Ground floor, 5, Netaji Subhas Road, Kolkata 700001 represented by its **Secretary** hereinafter referred to as the Second Party (Which term or expression shall unless excluded by or repugnant to the context, be deemed to mean and include its successor in office, representatives, administrators, and assigns) **OF THE OTHER PART.**

WHEREAS **BARRACKPORE RASTRAGURU SURENDRANATH COLLEGE, BARRACKPORE** and **KOLKATA INSURANCE INSTITUTE, KOLKATA**, recognizing the value of cooperation, have agreed to enter into this Linkage Agreement regarding knowledge exchange in the field of Insurance Education. The purpose of this non-binding linkage is to make possible and institute academic and Linkage for knowledge exchange specially in the field of Insurance Education between **BARRACKPORE RASTRAGURU SURENDRANATH COLLEGE, BARRACKPORE** and **KOLKATA INSURANCE INSTITUTE, KOLKATA**, based upon the principles of mutual equality and the reciprocity of benefits.

NOW AGREEMENT WITNESSETH and it is agreed by and between both the Parties hereto as follows:



1. Each party will accept visiting members from the other party.

2. That the activity exchange program shall include exchanges in terms of knowledge specially in Insurance Education and the exchange of research materials, publications, and information to facilitate academic interchange between the parties of this Linkage Agreement.
3. The number of members under the activities exchange program shall be as per the requirement of the activity, and shall be decided and settled prior to the program between the signatories of this agreement.
4. The Agreement shall stand valid for a period of Two years from the date of its execution. However, it shall be automatically renewed unless any party hereof communicates for its termination, with a prior written notification to the other Party, at least six months prior to the date of its expiry.
5. Both Parties shall comply with the relevant laws in the jurisdiction in which it is in situated, and that all the visiting members from either of the organisation shall comply with all relevant laws in the jurisdiction of the host party.
